

TECHNICAL SESSION I: INTELLECTUAL PROPERTY RIGHTS

"Current Dimensions in Social Science and Commerce 2022"

The inaugural function of the conference was followed by the first technical session. The topic of the first technical session was 'Intellectual Property Rights'. The resource person for this technical session was Dr. Vinayak M. Govilkar, Chartered Accountant, Nashik and Former Principal, BKY College of Commerce, Nashik. He shared his in-depth knowledge on the topic 'A Primer on Intellectual Property Rights'.

At the outset of his presentation, Dr. Govilkar threw light on the theme of Intellectual Property Rights. He mentioned that human beings have four unique things. They are the mind, intellect, memory and ability to work through which human beings could discover the things. He said that the inventions make human life better, safe and comfortable. Inventions made by human beings involve their intellect and thus, the Intellectual Property Rights are an outcome of their investment of time, energy and money. Thus, the Intellectual Property Rights is a credit for the work on an individual.

He further mentioned that the Intellectual Property Rights are the rights bestowed upon by the law of the land. There are different Acts for different types of IPRs. The inventor has disclose his invention and has to apply for the right and has to comply the procedural formalities. The Intellectual Property Rights are for specific period and the person other than IPR is excluded from using the invention. The Intellectual Property Rights include copyright and other related rights, trademarks including service marks, geographical indications including appellations of origin, industrial designs, patents including the protection of new varieties of plants, layout designs of integrated circuits and undisclosed information including trade secrets and test data.

In his address to the audiences, Dr. Govilkar stated that the Intellectual Property Rights bestow the IPR holder the right to use, produce, import, sale and distribute, right to assign and license, right to surrender, right to additions, right in case of infringements and the right to apply for protection in other countries. He concluded his address with the remark that the Intellectual Property Right is a best source of recognition of one's work through which an IPR holder can draw the benefits of licensing, sale and merchandizing. The session was compared by Mr. S. R. Lonbale and Dr. V. V. Lade proposed vote of thanks.




TECHNICAL SESSION II: CAREER ADVANCEMENT SCHEME AS PER UGC GUIDELINES
